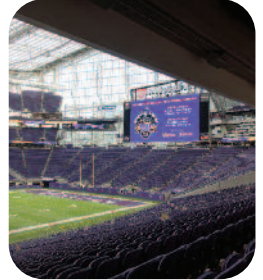

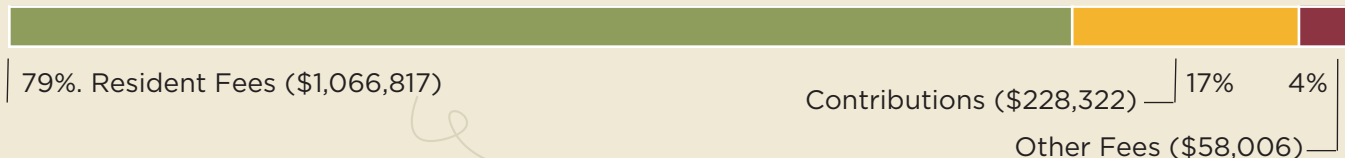

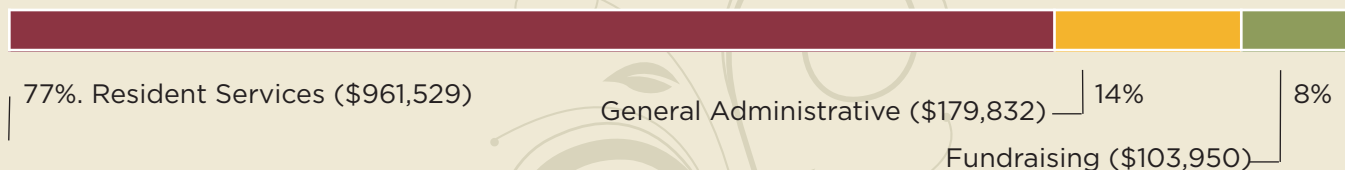

During 2106, Gianna established the Steve and Mary Mattson Fund to help defray the fees incurred when a current resident goes on assistance. The fund was gifted a \$50,000 match by Steve and Mary Mattson.
